No analysis of samples taken from animals on the holding or other samples has shown that the animals in this consignment may have been exposed to any disease or condition that may affect the safety of meat or a substance likely to result in residues in meat. The Livestock sold is fit for human consumption and comply with the requirements of the Food Safety Act 1990 and other applicable enactments.

The holding is not under movement restriction for Bovine Tuberculosis (TB) and all animals entered for sale have been Pre-movement tested in accordance with DEFRA Bovine Movements Regulations for 1 year testing zones and where applicable, with copy of TB test certificate attached. Cattle on the holding are not under any movement restrictions for other animal disease or public health reasons, and all stand still restrictions have been obeyed.
